

BEST SEAT INSIDE THE STADIUM SWEEPSTAKES:

I. ADVANCED AUTOPARTS.

Champps and WMVP (AM), and its licensee Sports Radio Chicago, LLC ("ESPN 1000") (Hereinafter collectively referred to as "Sponsor").

II. ELIGIBILITY
